New Construction Example-

Permit Fee = Square Foot x Construction Cost x Permit Fee Multiplier (0.0016)

2,000 sq ft single family residence, Type VB construction.

2,000 x \$170.80 x 0.0016= \$546.56

Plan review + Permit fee + Land Disturbance (less 1 acre)

\$150.00 + \$546.56 + \$200.00= \$896.56
