## **Grease Interceptors**

All restaurants and food establishments must have their grease interceptors inspected by a City employee each time the grease interceptor is pumped or maintenance work is performed. There will be an annual fee of \$100.00 dollars for these inspections. 706-778-6467

## **Fire and Sprinkler Taps**

A permit along with detailed plans are required and will be reviewed by the Fire Marshall and Utilities Department. The cost of the inspections and plan reviews are the responsibility of the developer or owner and costs will be assessed on a case by case basis. The construction and material cost of the tap and the meter are also the responsibility of the developer or the owner.

**The Developer must install according to specs. City will inspect tap and meter installation.**

The Property Owner must provide his/her own shut off valve. Using the turn off at the meter is not permissible.

Each parcel of land to be served by the city's water system shall be served by its own individual meter.

A water meter can be relocated on the same parcel of land after making application and paying the cost estimate prepared by the Public Utilities Director.
